 - i. From Laura S. regarding COTA membership and attendance to conference: I would love to discuss with the board/council ideas about how to get more OTA students/new grads to the conference. I have discussed this with Rachel casually via email, so I'll try to give my background information and data and then ask for input. My first year I was able to bring about students to conference but it was at a much lower student price and it was offered as a way to complete part of an assignment. This year I don't have any attending that I know of-I need to change the assignment for next year to make conference look like a more reasonable option, but the cost was also a factor this year. The other outlier information is that conference is earlier this year and we haven't even had SOTA elections yet and these students barely understand the basics at this point (it's only the 4th week of their first semester). The main problem with getting participation in conference from the OTA program is that once admitted (after prerequisites), they are in and out in 3 semesters. So fall conference is in their first semester of OTA school, and they are graduating in August and are either starting new jobs and possibly don't have time off or are not employed and have no money either way by the time their "second" September rolls around and they are not considered a student at that point. I would love to hear the options of everyone about what we could possibly offer to capture this population. My thoughts are for there to be an option for a "4th semester" student option for those students who had just finished in August to attend at the student rate (is there any wiggle room on this rate? It might be cost prohibitive for OTA students) when they finally would understand and be able to participate more at the

conference, and/or also a new grad option for ALOTA for 1-2 years possibly? After since a good number of our students are just landing PRN jobs and not full time jobs. Doesn't AOTA have a new grad rate that is for 1-3 years after graduation? Am I dreaming this? I did a poll in my last two groups on facebook and 54 students replied to my poll. They all unanimously answered that they would attend if it was less expensive/there was a new grad rate. I got less of a response on what would be a fair price, but I heard \$75 student/\$100-150 new grad would be fair.

 - 3. Paying per day option for conference
 - a. Can be a challenge due to attrition. So potentially could be offered students only.
